Position Responsibilities:

This is a fully online/remote full-time teaching position. All applicants must be physically located within the United States. The primary responsibility involves teaching asynchronous upper-level (300 and 400) information technology courses using Canvas. Course topics include but are not limited to network management/security, data management, security applications, project management, disaster recovery, server administration, and risk management.

Additional responsibilities include mentoring/advising students, participating in faculty/ad-hoc committees, and attending university-wide meetings. Course development, curriculum development, evaluation of degree and student learning objectives, and the review of degree programs are also expected.

Furthermore, a significant role involves fostering collaboration with industry partners and alumni and establishing academic partnerships with prominent IT industry leaders like Microsoft, SANS Institute, ISC2, and EC-Council. This engagement with external stakeholders contributes to the enrichment of the academic experience, ensuring our IT degree programs align with industry standards.

Required Qualifications:

- **Graduate degree in Information Systems/Technology, Computer Science, Cybersecurity, Data and Information Science or a closely related field**
 - Minimum of 18 graduate semester hours in field
- Online teaching experience
- Online course development
- Commitment to undergraduate education, professional growth, service, and scholarship in a distinctively Christian setting, including agreement with the University's mission and goals, values, and doctrinal statement
- Strong analytical, communication, interpersonal, and research skills
- Must be physically located within the United States

Preferred Qualifications:

- Terminal degree in Information Systems/Technology or Cybersecurity
- Industry and practical experience
- IT/cybersecurity certifications from industry leaders such as CompTIA, Cisco, Microsoft, SANS Institute, ISC2, EC-Council, or AWS
- Expertise in one or more of the following: data analytics/business analytics, artificial intelligence, database systems, cloud computing, computer networking, information assurance/security, and cybersecurity
- Proficiency with learning management systems (e.g., Canvas, Blackboard, D2L, Moodle)
