

## **ARP (HEERF III) Student Portion Initial Report for June 11, 2021**

Point University is reporting the following:

Point University was awarded supplemental funds under CRRSAA on January 17, 2021 (which were previously completely distributed and reported on), and under ARP on May 20, 2021, currently being reported here. The Department of Education included language in the Grant Award Notification stipulating that drawing down any amount of the supplemental funds constitutes our acceptance of the new Supplemental Agreement for the program. We did not have to sign and return a new agreement. As with CRRSAA, we will confirm our acceptance of the Supplemental Agreement for ARP by drawing down the funds.

Point University acknowledges that it has and will continue to use the amount of funds designated under the CRRSAA and ARP programs for Emergency Financial Aid Grants to Students to provide those grants to students.
