## Position Responsibilities:

This is a fully online/remote adjunct teaching position. All applicants must be physically located within the United States. The primary responsibility involves teaching asynchronous information technology courses using Canvas.

Course topics include but are not limited to introduction to information technology (CompTIA ITF+ preparation), information technology applications I and II (CompTIA A+ preparation), operating systems, network management/security (CompTIA Network+ and Security+ preparation), data management, security applications, project management (CompTIA Project+ preparation), risk management (ISACA IT Risk Fundamentals preparation), disaster recovery, and server administration.

## **Required Qualifications:**

- Graduate degree in Information Systems/Technology, Computer Science, Cybersecurity, Data and Information Science or a closely related field
  - Minimum of 18 graduate semester hours in field
- Online teaching experience
- Online course development

- Commitment to undergraduate education, professional growth, service, and scholarship in a distinctively Christian setting, including agreement with the University's mission and goals, values, and doctrinal statement.
- Strong analytical, communication, interpersonal, and research skills
- Must be physically located within the United States

### **Preferred Qualifications:**

- Terminal degree in Information Systems/Technology, Computer Science, Cybersecurity, Data and Information Science or a closely related field
- Industry and practical experience
- IT/cybersecurity certifications from industry leaders such as CompTIA, Cisco, Microsoft, SANS Institute, ISC2, EC-Council, or AWS
- Expertise in one or more of the following: data analytics/business analytics, artificial intelligence, database systems, cloud computing, computer networking, information assurance/security, and cybersecurity
- Proficiency with Canvas LMS
